Mrs. Abele motioned to approve the January 2, 2024, Meeting Minutes as presented, second by Mr. Houghton. Motion carried 3-0.

## TREASURER'S REPORT

Mr. Yaich reported on fund activity for the year to date and presented a list of bills to be ratified. Mr. Yaich noted that the approval of the bills should include the withholding of a check to Minquas Ambulance until more information is obtained with respect to their financial status. Mr. Houghton motioned to pay the bills as presented and ratify the payroll, second by Mrs. Abele. Motion carried 3-0.

B. Ordinance #22-02 – Design Review Committee

Mr. Houghton motioned to authorize the Township Manager to advertise Ordinance #22-02 updating the Design Review Committee, second by Mrs. Abele. Motion carried 3-0.

C. Ordinance #23-08 – Amending the Property Maintenance Code and adding Zoning Definitions Mark Slouf – 416 Cann Road – stated several objections he had to the proposed Ordinance #23-08 with respect to trees in the Township right of way.

Mr. Houghton motioned to authorize the Township Manager to advertise Ordinance #23-08, updating the Property Maintenance Code and adding certain Zoning definitions, second by Mrs. Abele. Motion carried 3-0.

#### D. Ordinance #23-09 - Fire Code Update

Mrs. Abele motioned to authorize the Township Manager to advertise Ordinance #23-09 updating the Fire Code, second by Mr. Houghton. Motion carried 3-0.

E. Ordinance #23-10 - Official Map

Mr. Hines opened the hearing for Ordinance #23-10 – Official Map.

Mrs. Venzie explained the proposed Ordinance as well as presented a series of exhibits to be included in the record. Mr. Hines discussed adding additional open space overlays to the map and continuing the hearing until next month.

Mr. Hines called for public comment. Roberta Ekdahl – 1751 West Strasburg Road – raised concern about the use of the Official Map. Mr. Hines continued the hearing until March  $12^{th}$ , 2024, at 7:00 p.m.

Mr. Houghton made a motion to establish the committee for the Act 209 Traffic Plan update.

G. Land Development Plan #23-01 – West Bradford Elementary School

Mr. Houghton motioned to approve Resolution #24-04 Preliminary/Final land development plan for West Bradford Elementary School, adding a condition to include a fee in lieu of trees consistent with the estimate provided to the Township Engineer, Matt Bush, and to correct the Traffic Impact Fee to \$1,806.00, second by Mrs. Abele. Motion carried 3-0.
