- B. <u>Conditional Use No. 48 1231 Marshallton-Thorndale Road Erickson-Accessory Suite</u> Applicant and Resident, Drew Erickson asked the Planning Commission to consider recommending the Conditional Use Application #48 to permit an addition to the existing single-family dwelling located at 1231 Marshallton-Thorndale Road to serve as an *accessory suite*.

C. Ordinance 23-03 – Agricultural Day Camp/Amendments to SALDO
Discussions were held on whether the Planning Commission should recommend the proposed zoning amendment to add provisions for Agricultural Day Camps to be adopted by the Board of Supervisors. Previous discussions were held on the previous draft of this Ordinance during the June meeting.

Mr. Klein motioned to recommend approval of the proposed ordinance on Agricultural Day Camps as an accessory to agricultural use, conditioned upon the vehicular entrance to be reviewed by the Township Engineer for ingress/egress, seconded by Mr. Cook. All ayes, motion carried 6-0.

Mr. Klein also made a motion to approve the amendments to the SALDO, as drafted, seconded by Mr. Dunn.
